Proposal Submission

Please submit a proposal of up to 500 words to urbanlaw@fordham.edu with "[Name of Proposed Paper, First Name, Last Name]" in the subject line of your email. If you have a draft paper, please include it with your proposal, but participants do not need to have prepared a paper to participate. The Conference will be conducted in English. Englishlanguage proposals are preferred but we will also consider submissions in Spanish.

Submissions are due no later than January 15th, 2026, although earlier submissions are encouraged. Proposers will be informed of their acceptance by February 15th, 2026.
